The three month investigation by the Pulaski County Sheriff's Department Criminal Investigation Division that resulted in the indictment of fifteen suspects on more than 100 counts of burglary and theft related charges has resulted in the arrest of six of the suspects since May 31, 2008. Arrested on the indictments are the following;

Bolin**, age 20, of 100 Circle Drive Burnside, Kentucky. **Bolin** was charged with, **5 Counts Burglary 1<sup>st</sup> Degree, 6 Counts Burglary 2<sup>nd</sup> Degree, 10 Counts of Theft By Unlawful Taking Over \$300, 5 Counts of Theft By Unlawful Taking (Firearm), 1 Count of Receiving Stolen Property Over \$300 and 1 Count of Receiving Stolen Property Under \$300.** (Arrested on May 31, 2008).
